**Registration dates:** January 9, 2017 – February 10, 2017

**Requirements for registering:** 21 years of age by February 23, 2017, high school diploma or GED, and not have been convicted of a felony or misdemeanor involving moral turpitude other than a minor traffic violation. The Police Department has a tattoo policy. For more information regarding the tattoo policy, inquire with Human Resources.

**To register, present the following to the Human Resources Department, 601 E. Main Street, Johnson City, TN 37601:**

- \$18.00 Non-refundable examination fee (must be paid by 2/10/2017);

- High School Diploma/GED or Transcript with Graduation Date;

## CIVIL SERVICE EXAMINATION

### GENERAL RELEASE AND WAIVER OF ANY AND ALL CLAIMS

**WHEREAS**, the undersigned has made application to the City of Johnson City for employment and which employment requires the undersigned to undergo physical agility testing; and

**WHEREAS**, the undersigned acknowledges that there is risk of injury and damage in participating in such physical agility testing and has agreed to voluntarily assume all of such risks; to waive any and all claims that the undersigned may have in any way arising from the participation in said testing; and to fully release and discharge the City of Johnson City, its officers, agents, employees, or representatives otherwise for any and all such claims, liability or responsibility or demand of any kind of nature.

**NOW, THEREFORE**, in consideration of the premises, the undersigned does hereby voluntarily waive any and all claim or claims and assumes all risk or risks of injury or damage to his/her person or property and does hereby release and discharge the City of Johnson City, its officers, agents, employees, or representatives otherwise, jointly and severally, from any and all claim, liability, responsibility or demand of any kind or nature, which may be sustained by the undersigned, whether or not caused by the negligence of the aforesaid City of Johnson City, or any of its officers, agents, employees, or representatives otherwise, whether or not they are acting in an official capacity or otherwise.

The undersigned spouse does hereby join in this waiver of claim and release for the purpose of waiving any claim that said spouse may have and releasing and discharging the said City, its officers, agents, employees, or representatives otherwise, upon the terms above stated and agrees to allow the testing of his/her spouse for the aforesaid purposes.
